I) Application Procedure:

- 1. Before applying, the candidates should ensure that he/she fulfils the eligibility criteria and other norms mentioned in the detailed Advertisement available on <u>https://aripune.res.in/jobs/</u>
- 2. ITI trade candidates may apply by logging into portal <u>https://apprenticeshipindia.org</u> by clicking on 'Apprenticeship Opportunities' and by typing in 'Search by Establishment Name' with 'MACS AGHARKAR RESEARCH INSTITUTE', (Establishment ID: E04242700119) and click Apply after choosing your respective trade.
- 3. The regular candidates who have completed the qualifying examinations (Graduate, Diploma and ITI trade apprentices in **2023**, **2024 and 2025** possessing percentage more than 50%), **are only eligible to apply.**
- 4. Reservation of posts for SC/ST/OBC(non-creamy layer)/EWS /PWBD candidates will be as per Govt. directives/Guideline.
- 5. Age relaxation for SC/ST candidates :-5 years, OBC :-3 years and PWBD :-10 years.
- 6. The last date for receipt of online application is **30.05.2025**. Online applications after the last date will **not** be accepted. Incomplete or partially filled applications will **not** be entertained.

II) Selection Procedure:

- 1. Selection will be made on the basis of Academic Merit / Interview as required, subject to satisfactory verification of the documents.
- 2. Shortlisted Candidates will be informed via **E-mail** mentioned in the application for correspondence. It is advised to check the emails periodically and keep the same active till completion of selection process. Administration of Establishment will **not** be responsible for non-receipt of communication due to change in mobile number/e-mail id.
- 3. Candidates are required to bring **Original and Self-attested** copy of documents mentioned below during document verification / joining :-

Documents to be carried:

- a. Signed printout of the Application.
- b. 10th Mark sheet and certificate.
- c. Degree / provisional Degree / Diploma / ITI certificate.
- d. Caste Certificate (if applicable).
- e. PWD Certificate (if applicable).
- f. Any Photo ID card issued by Govt. of India like PAN Card / Voter ID / Driving License.
- g. Aadhaar Card (Mandatory).

i. Copy of Aadhaar Seeded Bank Pass Book/Statement [Note: It is mandatory to have Aadhaar Seeded / linked Bank account].


j. Two Passport size photographs.

- 4. Candidates selected for training will not be allowed to withdraw from training except for reasons which are beyond their control. Before commencement of training, the candidate will have to execute a contract of apprenticeship in the respective portals.
- 5. Selected Candidates will have to produce valid Character Certificate at the time of joining.

- 6. No correspondence shall be entertained from the candidates **Not** selected for Apprenticeship training.
- 7. The Management reserves the right to amend / refix / cancel / suspend / the selection process at any time during the process without assigning any reason whatsoever. The decision of the management shall be final and binding and no appeal of any kind shall be accepted / considered in this regard.

III) Instructions:

- 1. Verification of documents shall be done for selected candidates prior to **Creation of Contract only** and in case of any deviation from or non-conformity with the desired qualification, candidature of the candidate shall be rejected.
- 2. All the qualifications must be from Indian Institutions recognised by Appropriate Statutory Authority.
- 3. Suppression of facts will also lead to disqualification, at any stage of the selection process or during the apprenticeship period.
- 4. Candidates who have already undergone apprenticeship training or at present undergoing apprenticeship training under any organization are **Not** eligible to apply.
- 5. Candidates with more than one year work experience are **not** eligible to apply.
- 6. No **TA/DA** will be paid to the applicants called for any stage of the selection process.
- 7. The apprentices will not be provided any Hostel Accommodation, Quarter and Transport by the establishment at the time of interview and also during the apprenticeship period.
- 8. The engagement and training are strictly in compliance with the provision of the Apprenticeship Act 1961 and there is no obligation for employment of apprentices on completion of their training.
- 9. Any canvassing or personal follow up during the process of selection of apprentice by and behalf of any candidate shall lead to immediate cancellation of candidature.
- 10. ARI reserves the right to terminate apprenticeship if circumstances so warrant without assigning any reason thereof.
- 11. In case of any dispute, the legal jurisdiction shall be that of the Courts at Pune.
- 12. The selected candidates should abide by the rules and regulations framed by the Institute from time to time.
