2. Non-refundable application fee of ₹100/- (except SC/ST/Divyang/Women Candidates) to be paid online through <https://www.onlinesbi.sbi/sbicollect/> (Steps to follow: Educational Institutions → Category → Agharkar Research Institute-MACS → Payment Category → Application Fee → Enter Necessary fields / details etc.). Candidates should attach indicate the online receipt number in the application form. The Institute is not responsible for any incomplete/pending/failed transactions of online application fee payments, and they may contact the concerned bank in this regard.
3. The prescribed essential qualifications are minimum and the mere possession of the same does not entitle candidates to be called for interview. The consideration of qualifications as equivalent' to the essential and desirable qualifications stated above shall be the discretion of the relevant committee constituted for scrutinizing the applications. If the number of applications received in response to advertisement is large, the Institute may restrict the number of candidates to be called for interview to a reasonable limit through a shortlisting process based on a well-defined criterion which may include possessing of desirable qualifications and / or experience more than that prescribed in the advertisement and/or qualifications/ experience in a particular field as per the specific requirement.
