Candidates fulfilling above conditions may apply online application link (<http://arijob.ourlib.in>) and attached with self-attested scanned certificates, recent Passport size photograph, caste certificate issued by the Competent Authority (for reserved category), receipt of online payment of fees {if applicable} on or before **17th February 2026**
2. Non-refundable application fee of ₹100/- (except SC/ST/Divyang/Women Candidates) to be paid online through <https://www.onlinesbi.sbi/sbicollect/> (Steps to follow: Educational Institutions → Category → Agharkar Research Institute-MACS → Payment Category → Application Fee → Enter Necessary fields / details etc.). Candidates should attach the receipt of online payment of fees and indicate the online receipt number in the application form. The Institute is not responsible for any incomplete/pending/failed transactions of online application fee payments, and they may contact the concerned bank in this regard.
3. The prescribed essential qualifications are minimum and the mere possession of the same does not entitle candidates to be called for interview. The consideration of qualifications as equivalent' to the essential and desirable qualifications stated above shall be the discretion of the relevant committee constituted for scrutinizing the applications.
