2. Non-refundable application fee of ₹100/- (except SC/ST/Divyang/Women Candidates) to be paid online through <https://www.onlinesbi.sbi/sbicollect/> (Steps to follow: Educational Institutions → Category → Agharkar Research Institute-MACS → Payment Category → Application Fee → Enter Necessary fields / details etc.). Candidates should attach the receipt of online payment of fees and indicate the online receipt number in the application form. 3. The prescribed essential qualifications are minimum and the mere possession of the same does not entitle candidates to be called for interview.
